Prior to joining Covina PD, Chief Curley served as a Reserve Officer with the Monterey Park Police Department. After obtaining his bachelor's degree from Cal Poly Pomona, Chief Curley was hired by the Covina PD and graduated as class president from Rio Hondo Police Academy Class #113. John worked in a variety of assignments and rose through the ranks becoming Chief on October 14, 2016. Chief Curley received numerous commendations and department medals and was also The Police Officer of the Year in 2000. Chief Curley earned a graduate degree from the University of La Verne and authored a thesis on the vision to regionalize law enforcement services in the

San Gabriel Valley. He was also selected as a member of Rotary International's Group Study Exchange Team where he spent over 1 moth in Japan learning about policing strategies and cultural diversity. During her time at UCLA, Ms. Johnson was a research assistant for Karen Saywitz, who studied child witness suggestibility, and volunteered as a Victim/Witness Assistant Intern for the LADA. Ms. Johnson obtained her law degree from the University of San Francisco and then came to work at the LADA as a Deputy District Attorney. She has been a Deputy District Attorney for 25 years. Many of Ms. Johnson's LADA assignments have caused her work with sex crimes and child witnesses. Ms. Johnson has conducted numerous

child interviews and still recommends children be interviewed by a forensic interviewer at a Children's Advocacy Center. As a Deputy District Attorney, Ms. Johnson had the rare opportunity to work in two roles on a Multidisciplinary team. First, she worked as a victim advocate while volunteering for LACAAW. Later in her career, she worked as a sex crimes prosecutor stationed at Stuart House, another Children's Advocacy Center in LA County. As such, she has seen firsthand the great benefits that Children's Advocacy Centers offer to a child victim or witness.



Sgt Michael Solomita has been with the Long Beach Police Department since 1997. He holds a Bachelor of Arts degree in Criminal Justice and Political Science from California State University, Fullerton; and a master's degree of Public Administration from California State University, Long Beach. He has worked various assignments within the police department but has spent most of his career investigating family violence and sexual assaults in the Special Victims Section. In 2013 he promoted to the rank of sergeant and returned to a patrol assignment. In 2015 he was transferred back to the Special Victim's Section and assigned to head up the Child Abuse Detail. The detectives in the Child Abuse Detail are primarily tasked with investigating cases of child neglect, physical abuse, and sexual assaults of victims under the age of 18 years.



Kathy Cady has been a prosecutor with the Los Angeles County District Attorney's Office since 1989. She has specialized in family violence, child abuse, and sexual assault cases and tried approximately 90 felony jury trials. She is currently the Deputy-in-Charge of the Victim Impact Program (VIP) and supervises deputy district attorneys who vertically prosecute cases involving sexual assault of adults, physical and sexual assault of children, elder abuse, family violence, stalking cases and hate crimes in the Los Angeles County District Attorney Pasadena Branch Office. She was previously the Special Assistant to the Director for the Bureau of Victim Services which assists victims of violent crime. She has lectured extensively on child physical and sexual abuse, the criminal justice system, victims' rights and services, restitution and victims with disabilities. She

has authored articles on child abuse. She currently serves on the Board of Directors of the Children's

Advocacy Center for Child Abuse Assessment and Treatment, the Advisory Committee of the Children's Advocacy Centers of California, the state accredited chapter of the National Children's Alliance, the National Crime Victim Law Institute whose mission it is to actively promote balance and fairness in the justice system through crime victim centered legal advocacy, education and resource sharing, and is an honorary advisory Board Member of Justice for Homicide Victims. She previously served on California Children's Justice Act Task Force and on the Board of Directors of Project Sister Family Services, a rape crisis center. Ms. Cady has drafted legislation and testified in Sacramento regarding bills relating to victims' rights and child abuse, most notably drafting legislation which resulted in the passage of Penal Code 868.4, allowing victims to use a facility or therapy dog when they testify in court.

Earlier this year, the Masonic Center for Youth and Families, which provides comprehensive, integrated behavioral health services for children and families struggling with mental health difficulties, opened an office to provide these extremely important support services to the abused children and their families who come to the CAC.

Therapy dogs have gained increasing attention in recent years because of the benefits they provide for children and adults. Currently the PPT visits over 150 sites throughout Southern California including hospitals, memory care centers, libraries, the Ontario Airport, working with police departments – most recently in human trafficking and, of course, the CAC. Since the beginning of 2015, PPT has become an increasingly effective partner with the CAC, providing comfort and a much-needed distraction for the child victims and families coming to the CAC for their forensic interviews. In 2015, PPT provided assistance to over 120 children and their families at the CAC.



Maryam Fatemi, MA, LMFT, is a Deputy Director of Los Angeles County Department of Children and Family Services (DCFS). She oversees all aspects of administration, protective services, and foster care for children who are victims of abuse, neglect, exploitation, or abandonment, as well as services to children at risk of maltreatment and their families in Service Bureau 1. She began her career with DCFS in 1984 as a Children's Social Worker. Maryam was a member of the CAC's Board of Directors for several years and continues to advocate the benefits of a

multidisciplinary response to child abuse investigations.



Los Angeles County Sheriff's Department Special Victims Bureau (SVB) is one of six highly specialized bureaus in the Detective Division of LASD. SVB investigates physical child abuse, sexual child abuse and on-line child sexual exploitation cases which occur within the Sheriff's Department jurisdiction. A child abuse detail was created in 1972. In January 2006, the unit evolved to what is now named SVB. SVB detectives and sergeants provide in-service training in child abuse laws and child abuse investigations to Department personnel

and to police officers from other law enforcement agencies. Presently, sixty-two (62) detectives are assigned to SBV which is comprised of six investigative regional teams. In 2015, SVB detectives investigated 4596 allegations of child abuse.
